Plant Sale:

NEW BUSINESS

Internet Domain:

Marc Teffeau moved that CCMG "purchase an internet domain name and supporting email services for the Cherokee County Master Gardeners. Estimated cost will be \$72 per year and will come from the Publicity line item in the current budget." Ed Stumler seconded the motion. Discussion ensued regarding the proposal to set up specifically a MailChimp account to mail out our bimonthly newsletter. *See the attached rationale for this purchase.* The vote was called for and the motion passed unanimously. Marc will move ahead with setting up the account.

Incorporation of CCMG as a 501(c) (3) organization:

Marc Teffeau moved that "Cherokee County Master Gardeners pursue incorporation of the organization as a non-profit corporation within the state of Georgia and file for tax-exempt status with the U.S. Treasury – Internal Revenue Service under Section 501(c)(3) of the U.S. Tax Code. Funding for the application process will be allocated from the Miscellaneous line item in the current budget." Ed Stumler seconded the motion. Discussion ensued as to the benefits of becoming a tax-exempt corporation. See the attached rationale for this purchase. The vote was called for and the motion passed unanimously. Marc will move ahead with consulting a local lawyer as the first step in the process. The Executive Committee believes the cost of legal and filing fees will run approximately to \$1310, with an annual renewal corporation fee of \$30.

Marcia reported that a good time was had by all at the plant swap and tour of Debbie Meadows' garden.

Comments: Fellow Master Gardeners:

This is to let you know that two motions will be presented at our June 21^{St} MG meeting under new business for your consideration and action. Supporting material for the motions is attached. Please note that only active MG's for 2016 can vote on the motions.

Motion 1: "To purchase an internet domain name and supporting e-mail services for the Cherokee County Master Gardeners. Estimated cost will be \$72 per year and will come from the Publicity line item in the current budget."

Note* - this will enable us to set up a MailChimp account our bimonthly newsletter and email it out. Motion 2: "Cherokee County Master Gardeners pursue incorporation of the organization as a nonprofit corporation within the State of Georgia and file for tax-exempt status with the U.S. Treasury - Internal Revenue Service under Section 501(c)(3) of the U.S. Tax Code. Funding for the application process will be allocated from the Miscellaneous line item in the current budget."

BACKGROUND FOR MOTION #1

FAQ - Frequently Asked Questions – Moving the Cherokee County MG Newsletter to MailChimp and Getting a "Domain" address

• Why do we need to consider getting an Internet "Domain" Address and supporting email account?

In setting up a MailChimp it is suggested that we purchase a "Domain" address for use as the email contact for the account. A Domain address is the URL for a website. www.uga.edu is a domain address. Email support will allow us to have specific emails associated with domain address.

• What is MailChimp?

MailChimp is an email marketing service and the trading name of its operator, a United States company based in Atlanta, founded in 2001. By June 2014 it was sending over 10 billion emails per month on behalf of its users.

• Why are we thinking about using MailChimp?

We are interested in getting broader distribution and readership of our bimonthly MG Newsletter – Gardening with the Masters. At the present time to access the newsletter one has to go to the Cherokee County Extension MG website. Use of MailChimp will allow us to "push" the newsletter out to a subscriber base rather than expecting them to be "pulled" into a website. MailChimp also has a number of attractive email templates that we can use free to enhance the look of our emails and newsletter.

• How would I get a "subscription" to the newsletter under MailChimp?

The newsletter would first be distributed to our current active membership of our MG group. We could then promote the newsletter by mass media and have "sign up" forms at our plant sales, seminars, programs and other events. Someone who is interested in getting the newsletter would sign up for it and allow us to add their email address to the subscription database.

BACKGROUND FOR MOTION #1

FAQ - Frequently Asked Questions – Moving the Cherokee County MG Newsletter to MailChimp and Getting a "Domain" address

Would we stop mailing the newsletter?

No. Presently, according to our records, we only have two paid mail subscriptions. As long as the subscriptions are paid the newsletter will still be mailed.

Would the newsletter still be posted to the website?

Yes. That would not change.

Can we use our MailChimp account for other emailing's?

Yes. We can use it to send out notices of our MG and other Extension programs, promotions for the Plant Sale and other MG activities which we would like to invite the public to attend.

Is there a charge to use MailChimp?

No, not at the level that we will initially be using it. Up to 2,000 subscribers and 12,000 emails per month is free. A subscriber base of 1,501 to 2,000 with unlimited emails is \$25 per month.

Who will do it?

The process is very simple, straight forward and not time consuming, just like sending an email. Hopefully an interested MG volunteer could be designated to be the point person to handle the "mailings." Estimated volunteer time would be one to two hours/month.

BACKGROUND FOR MOTION #2

FAQ -Frequently Asked Questions on 501(c)(3) – Non-Profit – Incorporation and Filing for Master Gardener Programs

What is 501(c)(3)?

Refers to the section of the Federal Tax Code that grants tax-exempt status to corporations which meet certain qualifications.

- What would the Cherokee County Master Gardeners do to obtain such status?
 - 1. File with the State of Georgia to incorporate Cherokee County Master Gardeners.
 - 2. File with the US IRS to request tax-exempt status.
- Why would Cherokee County Master Gardeners want to incorporate and obtain non-profit status?
 - 1. From a liability standpoint it would provide additional protection to MG volunteers from personal liability concerns. Currently MG's are covered under UGA policies.
 - 2. It would enhance our fundraising abilities and provide added financial support for enhanced Master Gardening activities and projects in the county. Currently we are limited in what larger projects and activities that we can do. Community groups such as the Lions Club, Rotary, and other civic organizations that have Federal tax exempt status can only provide donations to other tax-exempt community organizations. 501(c)(3) designation would also allow us to solicit contributions from individuals. Local and national businesses such as Home Depot, Walmart and others have community grant programs to which we could apply. State and National non-profits also have community grant programs available for local non-profits.
 - 3. We could solicit sponsorships for specific programs and projects.
 - 4. It would allow us to accept and manage tangible assets such as equipment and real estate.
 - 5. We would have a more formal and organized structure.
- What changes would we have to make to the organization administratively?
 - Revision of the by-laws as needed and development of the Articles of Incorporation.
 - 2. Changes in the financial management of the organization as needed.
 - 3. Annual filings to State of Georgia and IRS-Form990-N

BACKGROUND FOR MOTION #2

FAQ -Frequently Asked Questions on 501(c)(3) – Non-Profit – Incorporation and Filing for Master Gardener Programs

How long would this process take?

With the State of Georgia, the incorporation process takes 5 to 7 days once the application is filed. The review and granting of Federal tax-exempt status takes longer. However, Federal tax law does allow the corporation to solicit funds as a 501(c)(3) while the application is under review.

What are the costs involved?

A local attorney will assist with the process. Legal fees will run approximately \$750. Filing

fees to the State of Georgia are \$160 and to the IRS \$400 for an approximate cost of \$1310. There is annual renewal corporation fee to the State of Georgia of \$30.

• What oversight would UGA have over the non-profit?

None. The corporation would be entirely separate from UGA and managed by a Board of Directors elected by active Master Gardeners.

• What other county MG groups have non-profit status?

Cobb, Carroll, Clayton, Coastal, DeKalb, Fayette, Gwinnett*, Master Gardeners of Central Georgia (Macon-Bibb & Houston), Madison, North Fulton, Towns- Union Master Gardeners Association
