Governor Deal Proclaimed January Radon Action Month

Governor Nathan Deal signed a proclamation declaring January Georgia Radon Action Month. In addition to signing the declaration, Governor Deal honored the three finalists of the Georgia radon poster contest.

The three finalists were from Clarke and Oconee Counties, beating out over 200 other entrants from around the state. The entrants later received awards at a ceremony on January 21st attended by members of the Southeast American Association of Radon Technologists and Scientists, the American Lung Association, and the University of Georgia.

Georgia Radon Educators at Work

A Record Number of Kits Distributed During National Radon Action Month

During January, the Georgia radon program distributed over 500 radon in air test kits to Georgia residents.

Additionally, the program taught seven classes to radon professionals, real estate agents, and the general public, with over 150 attendees. More than 15 Georgia newspapers published stories on radon, and two radio stories were broadcast on local radio station WUGA.

The Program continues to work with local organizations to educate the public on how to test for radon, fix radon problem, ultimately saving lives.

Real Estate Professionals Taking Increased Interest in Radon

On January 15, 2019, the Georgia Radon Program taught a workshop to a group of 45 real estate professionals in DeKalb County. The agents had the opportunity to interact with the state radon map, see examples of short-term radon test kits, and ask questions about the differences between testing in residential homes versus real estate transactions.

In addition to this program, real estate professionals attended several programs open to the general public in the first quarter of the year. Two programs are scheduled in upcoming quarters as a result of real estate professionals bringing information from programs back to their respective companies.

The Georgia Radon Program will continue to target real estate professionals in its future programming. Several agents have expressed interest in becoming advocates in their community, and the program hopes to capitalize on their interest.
